- The Development Office at a pivot point and looking at things that need to be done, including a robust annual fund, major gifts campaign, planned giving, and online giving campaigns throughout the year
- The Office has been very short-staffed for years, but adding staff soon
- Grants program continues to be strong, and the progress with the Ford Foundation has been particularly positive
- Anticipating ending the fiscal year at \$1.3 million, which is well short of the \$5 million budget, but still a marked improvement from recent past years (the goal in 2020 was \$150,000)
