He stated three goals for his presidency: 1) must support, recognize, and showcase library workers as we confront, 2) stronger worker relationship between ALA and constituents 3) stronger ALA international programming. because what we do is powerful and holds impact in the world. If elected, I support three hirings: Director of Development, Director of Legislation, and for an ALA Executive Director to uplift and reflect the voices of membership. Focus on structure to strengthen work.

Ray: We are seeing an increase of dis- and misinformation, but there have been improvements since 2016. For example, more partnerships between libraries and journalists. Ray mentioned an open source toolkit (content authenticity initiative) that a journalist is part of and they will be presenting at the Louisiana Library Association conference. Noted that a lot of libraries lack training because they are understaffed. See opportunities to provide collaborative training.
