## YALSA Board of Directors Meeting ALA Annual Conference, Anaheim June 26 – July 2, 2008

**Topic:** Student Schola

5. Administration of the award (jury structure & charge)

A 3 person jury will be formed and will work virtually—no in person meeting is necessary since the applications can be submitted electronically.

The jury's charge is to select an applicant who demonstrates genuine interest in pursuing a career as a librarian serving teens.

One of the jury members must attend the conference and act as a mentor to the scholarship winner. The mentor will work with the winner to coordinate a schedule that will give the winner a complete ALA experience.

6. Screening of nominations (eligibility, award criteria, nomination process, voting procedures)

Any student currently enrolled in an ALA Accredited Masters program who has demonstrated interest in Young Adult/Teen librarianship may apply. The student's demonstration of commitment will include a written report to the Board and participation (either in person or virtual) on a YALSA member group after attending the conference. The award winner will also submit copies of expenses to demonstrate the use of the award funds. The award winner will also be a guest blogger on the YALSA blog and share impressions of conference attendance, YALSA, programs and such.

The application forms will be similar to the Baker & Taylor award form and will include a list of relevant coursework, involvement, recommendations from other librarians, and a short essay. Questions to direct the short essay:

- a. What do you hope to learn or experience at the ALA Annual Conference?
- b. Describe your vision for library service to teens over the next 3-5 years.
- c. Tell us about your experience working with teens, either professionally or as a volunteer.

The jury will meet virtually and discuss each application. A simple majority will decide the winner.

- 7. Presentation of award (given when, by whom & how)
  Announce at Midwinter Meeting, present certificate at Annual Membership Meeting.
  Check is delivered to winner prior to Annual Membership meeting.
- 8. Form &/or type of award (cash, plaque, etc)
  Up to \$2,000 to cover the cost of travel, housing, registration and some events.
- 9. Funding, expenses, revenues (from endowment, sponsor, etc.)
  Recommend a corporate sponsor be found for this scholarship, to be determined by YALSA.
- 10. Catalog description of award (how you want it to read in the ALA Handbook)

  To select annually one student in an ALA Accredited Masters program who has
  demonstrated interest in Young Adult/Teen librarianship to receive the XXXX/YALSA
