**Action Required:** Discussion

Questions the Board should be asking to facilitate the evaluation of YALSA's products and initiatives (adapted from the *Nonprofit Board Answer Book*,  $2^{nd}$  ed.):

- 1. How does this program relate to our mission and strategic plan?
- 2. What were the program's initial goals? Have those changed over time?
- 3. What's the annual budget? What is the cost per member?
- 4. Why should we continue to do this? What are the tangible and intangible benefits?
- 5. How successful is the program at meeting its goals?
- 6. Is there a more effective, efficient or inexpensive way we might achieve these same goals? If so, what is it?
- 7. What value does the program have in relation to others? Where on the list does it rank?
- 8. What official member groups (such as committees) support these programs? Do official member groups exist that support none of these programs? If so, what is their purpose in relation to the mission and strategic plan?
- 9. Are there portions of the strategic plan that are not addressed by any existing programs? If so, how might that be addressed?
- 10. If this program should be continued, how might it be improved or combined with another initiative? What are the financial and staffing implications of these changes?
- 11. If this program should be discontinued, what are the implications? What exit strategy should we employ?
