Background: In February the YALSA Board discussed, in their ALA Connect

space, the 2011 Midwinter Meeting document #31. (This was a document the Board was unable to discuss at Midwinter 2011, due to

a lack of time). Document #31 presented a proposal for the launch of a

YALSA Board Fellow program. The proposal was approved in

concept during the Board conference call in March with the next step the development of a set of guidelines for the Board to discuss at their meetings at Annual 2011. Mary Hastler and Linda Braun worked on the guidelines, which are is presented below for board consideration.

Action Required: Action

Overview

Each September YALSA will announce availability of an application for an association Board fellow. YALSA members who have not sat on the YALSA Board previously will be invited to submit an application for consideration as a Board fellow. An Ad-hoc Committee of the Board

At the end of their service, each Board fellow will be asked to complete an evaluation of his or her term by taking part in a phone interview with the immediate past president of the association.

Application

In order to apply to be a YALSA board fellow the applicant must be a YALSA member and be able to:

- attend all meetings of the Board at Midwinter and Annual;
- actively participate in virtual discussions in between face-to-face meetings;
- participate in work as assigned by the President;
- attend conference call meetings;
- participate in periodic trainings held virtually throughout the year;
- complete an evaluation of the board fellow experience;

The applicant cannot have served a term on the YALSA Board previously either as an elected or appointed ex officio member.

In compliance of the award and selection committee conflict of interest policies, members on these committees are not eligible to serve as a Board fellow, Section 1 B states, "Any member who is already on a YALSA award or selection committee may not serve on an Association Board or an ALA jury (ex. the Schneider Family Jury)." - http://ala.org/ala/mgrps/divs/yalsa/aboutyalsa/conflict.cfm

Those serving on a YALSA process committee (either as a member or chair) are eligible to apply as a YALSA Board fellow. It is important however to consider the time commitment required of committee work and Board work.

In order to be eligible as a Board fellow the candidate needs to not exceed the number of groups within ALA on which members are permitted to serve at one time. ALA Policy 4.4 states: "No person shall concurrently serve in more than three separate positions. Governing board, committee, liaison, subcommittee, and other responsibilities that require service in another position (e.g., service on a committee which entails assembly representation) are not in conflict with this policy."

YALSA will provide the Board fellow with a \$500 stipend to attend Midwinter Meeting and a \$500 stipend to attend the Annual Conference during the year of their fellowship.

The Ad-hoc Board Committee will vet applications and applicants will be informed of the status of their application by January 31.
