<u>Update</u>: I have only been to one meeting, and that was the one at the past Annual (June '07), so to be honest, I have not done much in the past 6 mos.

However, there is one development in the works which pertains to YALSA that I can pass along to you.

At Annual the Accessibility Committee was working on forming an ad hoc advisory committee on web standards. The (ad hoc) committee would exist to devise standards for libraries to keep in mind when choosing database vendors or web designers. These standards would pertain to accessibility for all types of users, with the goal of libraries only offering technology that is universally accessible. The (ad hoc) committee would also serve as a watchdog for best applications of these standards in the digital library world. They asked for a representative from our Outreach to serve. I asked if anyone was interested, and no one felt comfortable volunteering. So, I volunteered myself. However, I know nothing about web standards, and I feel like the wrong fit for this role. Could I ask other committees if anyone else would be interested?

I have not heard about any upcoming meetings of this ad hoc committee yet, so perhaps I should ask the chair about that. They would like all divisions represented on it. Perhaps I should get some clarity on the status of this committee before I proceed.
